## **AGREEMENT ON ACADEMIC AND SCIENTIFIC COOPERATION**

**Between**

**MOSCOW UNIVERSITY OF FINANCE AND LAW MFUA  
(Moscow, Russian Federation)**

**And**

**HINDUSTAN UNIVERSITY  
(Chennai, India)**

In recognition of common interests shared and as an expression of the desire to expand and strengthen the relationships between two universities, having the same goals in academic and scientific cooperation, **Moscow University of Finance and Law MFUA** (Russian Federation) 8, build. 1, Presnenskaya Embankment, MIBC “Moscow-Citi”, IFC “Capital City”, Tower “Moscow”, Moscow, Russia, 115114 and **Hindustan University (Hindustan Institute of Technology and Science)**, having its registered office at No. 40, G.S.T Road, St. Thomas Mount, Chennai – 600 016, India hereby enter into the following agreement.

### **Article 1**

The objectives of the Agreement are to promote and to coordinate the cooperation of both Universities in education and research.

### **Article 2**

Both Universities express a shared interest in the following activities:

- exchange of scientific and methodical materials, curriculum and other academic information,
- carrying out joint research projects,
- short and long-term visits of research and teaching staff, PhD students for consultations and lecturing,
- exchange of students for study programs,
- exchange of students for language training,
- joint development of existing curriculum,
- joint academic programs,
- organisation of joint seminars, workshops and specialised courses,
- joint cultural exchange programmes.

### Article 3

The implementation of this Agreement is a base for the cooperation of the contracting faculties and their departments and depends on the availability of funds for joint activities. Particular common activities will be implemented by a separate agreement, in writing. The contracting Universities will do their utmost to find the financial support necessary to make the present Agreement coming into effect. All commitments, obligations and expenditures related to any project approved under this Agreement shall be administrated in accordance with each University's practices and policies and the specific terms and conditions of funding agencies.

### Article 4

This Agreement shall remain into effect for a period of five years from the date of signing by both Universities and be subject to extension. Each University may terminate the Agreement by giving six month's written notice. Any joint project activity undertaken between the both Universities may be terminated by mutual agreement between the both Universities with three months' written notice by either University.

### Article 5

This Agreement is written in English in two copies, one copy for each side. It will come into force from the date of its execution, after approval by responsible authorities of each University.
